Introduction:

Bangladesh graduating from LDC is now a developing country. Youth are the main driving force in development process. They are social actors of change and progress. Their participation in development process should be encouraged in all possible ways. Their contribution, therefore, is highly needed in the journey of development.

The motivation, determination and high energy of the youth can make all the difference in building a nation. Proper guidance and direction can bring the youth in the forefront of national development. The youths have passions, dreams and hopes. They have bubbling enthusiasm which has to be regulated and utilized in the right way. This can surely ensure rapid development of nation.

To make youths responsible, self-confident, self-reliant and to transform them into disciplined productive workforce the Government of Bangladesh created Ministry of Youth Development in 1978 which subsequently renamed as Ministry of Youth & Sports. Department of Youth Development (DYD) was created on 1981 to perform field level youth activities.

As per National Youth Policy, those in the age group of 18-35 years are considered to be youth. According to the Population Census and Household Survey 2011, total youth population in Bangladesh is 4 crore 80 lakh 24 thousand 704 and they constitute about one-third of the country's total population. Keeping this in view, the Department of Youth Development since its inception has been trying relentlessly to transform the promising, productive and job seeking youth force into disciplined, organized and skilled workforce so that they can engage themselves in mainstream

development activities of the nation. It is indeed mentionable that transforming Bangladesh into a digitalized country by 2021, achieving SDGs set by UN and even transforming Bangladesh into a developed prosperous country by 2041, we have no option but to utilize the bulging youth population of the country as main workforce.

Since the inception (1981) of the Department of Youth Development (DYD) until June 2022, it has imparted training to 67,65,049 youths on different trades, with a view to creating employment and self-employment, and out of them 23,32,441 trained youths have engaged themselves in self-employment projects. Amongst these, in the fiscal year (2021-22) 3,00,174 youths have been trained and 48,104 are self-employed. For establishment and extension self-employment projects since the inception of the microcredit programme of the department till June 2022 an amount of Tk. 225593.00 lakh was disbursed to 10,23,931 trained youths as loan from principal capital and revolving fund. Moreover, an amount of Tk. 15098.66 lakh was disbursed to 43,793 trained youths as loan during the fiscal year 2021-2022. The average rate of loan realization is 95.21%. The monthly income of self-employed youth ranges from Tk. 10,000/- to Tk. 1,00,000/-. But in some cases successful self-employed youth earn more than one lakh taka per month. Moreover, a good number of trained youths have obtained jobs in different organizations at home and abroad by the time. In fact, DYD is proceeding ahead in creating self-employment and employment opportunity across the country.

Areas of Work

The Department performs the following activities as per the "Rules of Business" of the Government:

 - Research and study on youths and youth development activities.
 - Promoting activities for creating employment opportunities for the unemployed and underemployed youths.

 To build modern life oriented youth with high ethics and values enabling to increase glory & development of Bangladesh.

Mission

 To establish youth in every sphere of life by developing their talents and ensuring empowerment.

Objectives

- To transform the youth as judicious, modern life oriented, self-dignified and positive person.

- To ensure quality education, health and secure healthy environment for the youth.

- To encourage youth to be volunteers for protection of environment, climate change and confront natural disaster as well as to engage them in nation building activities.
- To sensitize the youth towards the social needs of the physically and mentally or otherwise challenged and backward people of the society.
- To ensure the rights of the youth of special needs.
- To motivate the youth to avoid the aggressive mentality and extremism in lifestyle.
 - To awake the liberal, non-communal, humane and global spirit among the youth.

Organizational set-up:

Department of Youth Development (DYD) is headed by Director General who is assisted by Six Directors and Project Directors of different projects together with the employees. DYD operates huge programmes through 64 districts and 491 upazila offices including 10 metropolitan unit thanas. To conduct training courses, the Department of Youth Development has 71 Residential Youth Training Centres and Non-residential Training Centres in 64 districts all over the country. The Department has a huge staff of 7185 in revenue sector apart from development budget who are dedicated to provide service to the youth in terms of their welfare and overall development of the youth.

Programmes of the Department:

To fulfil its objectives in tune with the visions, the following multifarious programmes are usually undertaken:

1. Skill Development Training:

Department of Youth Development (DYD) conducts two types of training programmes. 1)Institutional training programmes and 2) Non-institutional/ mobile training programmes. Institutional training programmes are residential and non-residential. Non-institutional/ mobile training programmes are implemented at upazila level according to local felt needs. Duration of institutional training courses is from 1 to 6 months while non-institutional training courses ranging from 7 to 21 days. Mobile Computer training courses are conducted at upazila level through ICT mobile training vans. Youth in the age group of 18-35 years take part in all training programmes of DYD. Target of training in the fiscal year 2021-2022 was 3,00,480 and 2,84,530 youths were trained. Target of training which is now on-going in the fiscal year 2022-2023 is now 1,69,009 youths.

3. Self-employment Programmes

Self-employment enterprise materializes through skill development training, motivation, group formation, credit and input support, close supervision, technical advice and development of marketing network. The monthly income of self-employed youths ranges from Tk. 10,000 to Tk.

1,00,000. In some cases, their monthly income exceeds Tk. 1 lakh. Trained youths may also enter into wage employment in different government and non-government organizations.

4. Credit Programme

Department of Youth Development has three types of credit programmes such as 1. Group Based Credit Programme 2. Individual Credit Programme & 3) Entrepreneurship Development credit Programme.

4.a) Group Based Credit Programme

The members of each group are to be blood-related or close neighbors. The number of group members is 5. The lowest ceiling of group based micro-credit is Tk. 12000 per group member and the highest ceiling is Tk. 20,000. A group member is entitled to loan for 3 times.

4.b) Individual Credit Programme

Trained youths are given individual micro-credit and they must be trained from Department of Youth Development. The lowest ceiling of individual micro-credit is Tk. 40,000 and the highest ceiling is Tk. 1,00,000. An individual is entitled to loan for 3 times.

4.c) Entrepreneurship Development credit Programme

Department of Youth Development is going to introduce a new credit programme to enhance self-employed youths into entrepreneur. Primarily this credit programme will be implemented in 8 divisional districts. An entrepreneur will be provided Tk. 3.50 lakh by two cross cheques for expansion of income generating enterprise. Loans up to Tk 2 lakh are provided to three persons in each upazila from among the youth who have turned self-employed into entrepreneurs.

5. Awareness and Motivational Programmes

Youths are given awareness and motivational training on reproductive health, prevention of HIV/AIDS, STDs, substance abuse, norms & values, gender issues and development, good governance, disaster management, behavioral development, environment conservation, civic education for responsible citizenship, primary health care, autism, protection of terrorism and extremism and social ills.

Budget Allocation in Youth Development Sector

01. National Service Programme

National Service Programme (NSP) is a high priority programme of present Government to fulfill the commitment of Election Manifesto for providing two years' temporary employment to the unemployed youths having educational qualification of H.S.C or higher. NSP first started as pilot programme in three vulnerable districts namely Kurigram, Borguna and Gopalgonj in 2009-2010. As per approved NSP operational policy, temporary employments are created for youths in different nation building organizations after completion of three months basic training on ten specific modules. The participants receive Tk. 100/- per day during training and Tk. 200/- while in employment. Under its 2nd

phase, the programme has been extended to the eight upazilas of Rangpur Division in 2011-2012 fiscal year and under the 3rd phase to the seventeen upazilas of seventeen poorest districts of the country in 2014-2015. 4th phase has been extended to the twenty upazilas of 7 districts in 2015-2016 and 5th phase to the twenty four upazilas of 15 districts in 2016-2017 fiscal year. Activities of 6th and 7th phases has been extended to the twenty upazilas of 13 districts and twenty upazilas of 14 districts in 2017-2018 fiscal year. Temporary employment of 1st, 2nd, 3rd and 4th phases and 1st part of the 5th phase have already completed. Temporary employment has been created in upazila administration, law and order protection department, schools, colleges, municipalities, union parishads, upazila hospitals, clinics, banks and different service providing government and non-government organizations. Up to June, 2020 a total number of 2,29,737 unemployed youths were trained of which 56801 in the 1st phase, 14515 in 2nd phase, 16342 in the 3rd phase and 26376 in the 4th phase, 37268 in the 5th phase, 51194 in the 6th phase and 27968 in the 7th phase. Out of them 2,27,402 were given two-year employment in different nation-building organizations. Amongst them, 56054 in the 1st phase, 14467 in 2nd phase, 14803 in 3rd phase, 26375 in the 4th phase, 37268 in the 5th phase, 51194 in the 6th phase and 27968 in the 7th phase. After completion of two years' temporary employment 12118 were employed in different government and private organizations and 50399 were self-employed. For implementing NSP, the government has allocated Tk. 3366 crore 84 lac while Tk. 3180 crore 82 lac was expended from 2009 to 2020. Allocation was Tk. 663 crore 93 lac 60 thousand in the fiscal year 2019-2020 and expenditure was Tk. 649 crore 49 lac in the same year. Government has allocated Tk. 249 crore 51 lac for NSP in the fiscal year 2020-2021. The National Service Programme will be

gradually rolled out to all other districts and upzilas of the country as per poverty map.

02. Training Programmes

Skill development productive training is a regular activity of Department of Youth Development. To transform unemployed youths into skilled human resources DYD has been implementing institutional and non-institutional training programmes. Institutional training is provided on residential and non-residential basis.

Livestock, Poultry Rearing, Fishery & Agriculture Training: Duration of the course is 3 months. This course is residential. The admission fee is Tk. 100/- and deposit money is Tk. 100/- (refundable). Training allowance is Tk.4500 per month for each trainee. Minimum educational qualification for admission is class eight pass.

Fish Preservation and Processing Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Producing Dairy Product, Selling and Marketing Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Shrimp and Scorpion Cultivation, Selling and Marketing Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Goat, Sheep, Buffalo Rearing and Primary Treatment of Livestock Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Agriculture and Horticulture Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500.00 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Poultry Rearing Management and Meat Processing and Marketing Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Milky Cow Rearing and Beef Fattening Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Mushroom Cultivation and Bee Rearing Training: Duration of the course is 15 days. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Flower Cultivation, Post Harvest Management and Marketing Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Ornamental Plant Production, Bonsai and Ekabana

Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Nursery and Fruit Cultivation Management Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/ trainee. Minimum educational qualification for admission is class eight pass.

Commercial Aquaponics Training: Duration of the course is 02 weeks. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.150 per day/trainee. Minimum educational qualification for admission is class eight pass.

Agricultural Equipment Repairing Training: Duration of the course is 02 weeks. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.150 per day/ trainee. Minimum educational qualification for admission is class eight pass.

Banana Fiber Exstract Training: Duration of the course is 02 weeks. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.150 per day/trainee. Minimum educational qualification for admission is class eight pass.

Mobile Servicing and Repairing Training: Duration of the course is one month. The course is residential and admission fee is Tk. 100/-. Training allowance is Tk.4500 per month/trainee. Minimum educational qualification for admission is class eight pass.

<u>Sweater Knitting Training:</u> Duration of the course is one month. The course is residential and free of charge. Minimum educational qualification for admission is class eight pass. This course is conducted under PPP.

<u>Linking Machine Operating Training</u>: Duration of the course is one month. The course is residential and free of charge. Minimum educational qualification for admission is class eight pass. This course is conducted under PPP.

03. Poverty Reduction and Micro-credit Programme

Youths live in poverty due to constraint of property. They cannot meet their fundamental needs such as food, cloth, nutrition, health and education because of unemployment and lack of property of their own. The main objective of the poverty reduction programme is to ensure a poverty free happy life for them through providing skill development training and micro credit support with easy terms and conditions. This is an ongoing programme in all upazilas of the country.

03. a) Family Based Credit Programme

This programme benefits the rural landless and poor people, especially the poor youths. The main objective of this programme is to help the families develop into units of economic activities. It is being operated in 310 upazilas of the country. This family-oriented approach attaches importance to family cohesion, traditional family occupation, women empowerment, health care, education, environment development and group dynamics. The members of each group are to be blood-related or close neighbors. A group consists of five members and the members are given loan for undertaking income generating activities. 7-10 groups make what we call a centre. The employees of DYD make themselves available at this centre to disburse and recover loan, thus removing the need of the members travelling to DYD offices. The lowest ceiling of group-based micro-credit is Tk. 12,000 per group member and the highest ceiling is Tk. 20,000. A group is entitled to loan for 3 times. In addition to it, provision of "enterprise loan" has been made for successful recovery of loan to 5 members in a centre following the credit manual of self-employment loan. Loan is realized with 5% service charge at a declining rate. Before disbursement of loan, the members are given 5 days orientation on loan management and loan recovery. The average rate of recovery is 96.70%.

After expiry of grace period, loan is to be repaid through monthly installments. Loan is realized with 5% service charge at a declining rate. The average rate of realization of loan is 94.36%.

Trained youth primarily arrange capital from their families to establish self-employment projects for income generation. Later on, Department of Youth Development provides credit support to expand and operate of self-employment projects. Their monthly income ranges from Tk. 6000 to Tk. 50,000. In some cases, their monthly income exceeds Tk. 1 lakh. Trained youths may also enter into wage employment in different government and non-government organizations.

05. Central Human Resource Development Centre

Central Human Resource Development Centre (CHRDC) was established in 1992 at Savar (opposite to bank town) near Dhaka on 5.59 acres of land for providing training to the officers and staff of the Department of Youth Development to enhance their professional skills, capacity and efficiency. It has infrastructural facilities like Administrative-cum-Academic Building, Hostels, Staff Quarters, Officers Quarters and Library. This centre was established under Upazila Resource Development and Employment Project but at present all activities of it are being implemented under revenue budget. They are also taught about primary treatment to protect their dairy, poultry assets. Total number of residential youth training centres is 64. Twenty one residential youth training centres have already been transferred in the revenue set-up and others is underway. 32 centres have been established under "Establishment of 26 New Youth Training Centers" project and "Establishment of 18 New Youth Training Centers (1st phase-8 centre)" project. Those were completed in June, 2006 and 2007 respectively but the

programmes still are in operation. Residential youth training centres are established on 1.50 acres to 7.00 acres of land. All centres have office cum academic buildings, male and female hostels, officers and staff quarters, duck cum poultry sheds, cow sheds, hatcheries, ponds, nursery units and playground facilities. Meanwhile, personnel of all other residential youth training centres have been transferred in the revenue budget. Programmes of all youth training centres are the same. Until June, 2020 total number of 3,61,954 male & female unemployed youths were trained through youth training centers. These YTCs can turn into role model for youth training of development if we can use them in full capacity by adding extra pace to their activities.

Electronics Training: Duration of the course is six months. The course is non-residential and course fee is Tk. 300/-. Minimum educational qualification for admission is SSC pass. Training allowance is Tk.100 per day/trainee.

Electrical & House Wiring Training: Duration of the course is six months. The course is non-residential and course fee is Tk. 300/-. Minimum educational qualification for admission is class eight pass. Training allowance is Tk.100 per day/trainee.

Refrigeration & Air-conditioning Training: Duration of the course is six months. The course is non-residential and course fee is Tk. 300/-. Minimum educational qualification for admission is S.S.C. pass. Training allowance is Tk.100 per day/trainee.

Ongoing Projects of DYD

01. Project for Training in Automobile Driving

This project has been taken to create employment and self-employment in the country by making competent drivers in automobile driving to stop road accidents in the country. Under

this project trainees will be able to take part in training in 40 centers of 64 districts. If this project runs successfully then 40,000 work-expecting youth and women youth will get opportunity to create employment and self-employment in the country and abroad by taking training on automobile driving. The duration of the project is from 01-01-2021 to 23-11-2023. 10594.00 lakh for estimated expenditure was approved in ECNEC meeting for the implementation of the project. Under the project Workshop, Training Track, Ramp has already been completed. Beside that purchase of scrap engine, traffic sign board, projector, computer and various equipment's for vehicle has been sent to 40 centers. Training programs are going on. 202 persons (manpower) have been recruited through outsourcing under the project.

02. Integrated Management of Resources for Poverty Alleviation Through Comprehensive Technology (IMPACT) Project (3rd Phase)

One of the objectives of this project is to meet the energy needs by producing biogas at the village level through the extensive use of the project by the self-employment project takers on cattle and poultry rearing. The implementation of the 2nd phase of the project was completed on 30-06-2019. As the 2nd phase of the project has been successfully implemented, the DPP of 3rd phase has been formulated as directed by the authorities. The duration of the project is from 01-07-2021 to 30-06-2024. 23600.00 lakh Taka is for the implementation of the project. The decision to formulate the RDPP was taken in the departmental 'Project Appraisal Committee' meeting on the date 19-05-2022. Accordingly, RDPP has been formulated on 19/07/022. The activities of this environmentally friendly project will be implemented in 492 upazilas of all districts of the country in the 3rd phase. A total of 32,000 biogas plants will be set up during the project period to meet the fuel demand. The establishment of these biogas plants will gradually improve the local environment.

03. Technology Empowerment Center on Wheels for Underprivileged Rural Young People of Bangladesh (TECUYB 2nd Phase):

Technology Empowerment Center on Wheels for Underprivileged Rural Young People of Bangladesh (TECUYB 2nd Phase) aims to expand computer training facilities to remote village level for the participation of underprivileged poor youth aged 18-35 years in computer training by reducing the skill and information technology gap between urban and rural youth. Under this project, training facilities are being delivered to the doorsteps of the youth through mobile ICT training vans (Minibuses). Each mobile ICT training van has all the modern facilities of computer training including eleven laptops, internet facility, multimedia projector, audio system, generator. Each mobile ICT training van stays in each upazila for two months and implements the training program. In this way, training program will be implemented in all upazilas (except Sadar Upazila) of each district according to demand.

The project was launched on 31-01-2022. The total estimated cost of the project is Tk.4618.00 lakhs.

The implementation period of the project is 3 (three) years from 01-01-2022 to 31-12-2024. Up to date total target of trainee is 12880. But at present the project activities are going on through 14 ICT training vans as the finance ministry did not give approval for the purchase of another 7 cars. Training allowance/travelling allowance at the rate of Tk.200/- per person per working day is provided to the participants from the project. Apart from this, entertainment allowance is provided to the trainees at the rate of Tk. 100/- per person per working day.

Objectives of the project: To create opportunities for participation in computer training for underprivileged youth in rural areas;

 Creating opportunities for free training by placing poor youth in their respective positions;

- Increasing the competitiveness of rural poor youth in ICT-related jobs;
- Bridging the ICT knowledge gap between rural and urban youth.
- > To provide training opportunities to disabled and backward youth of Char area.

Youth development will take place in this training. Ensuring participation of youth forums in national policy making dialogues. The project will be implemented during the period 2022-2027.
- 13. International Labour Organization, Bangladesh: The Improving Skills & Economic Opportunities of Women Youth in Cox's Bazar District project implemented by the Directorate of Youth Development with its financial and technical support in collaboration with ILO Bangladesh with other activities including materials the existing training to institutional non-institutional training trades of the Directorate with youth aged 18 to 35 years at Cox's Bazar district and upazila level. By creating opportunities for young women from remote areas to participate in various trainings on a priority basis, it will make them self-reliant and turn them into assets and establish them in a respectable position in society. The main objectives of the project are:

OTHER PROGRAMMES

(a) National Youth Day

National Youth Day is celebrated on 1st November every year by the decision of the Government of the People's Republic of Bangladesh. Successful male and female youths and youth organizers who made outstanding contribution to self-employment and social services are given National Youth Awards on this day. Up to now the National Youth Awards have been given to 498 successful male and female youths including 44 youth organizers. This year 21 successful self-employee and youth organizers will be awarded the National Youth Award 2022.

(b) International Youth Day

The General Assembly of UN endorsed the recommendation made by the World Conference of Ministers Responsible for Youth (Lisbon, 8-12 August 1998) on 17 December 1999, in its resolution 54/120 that 12 August to be declared as "International Youth Day" and requested all member countries to observe this day with due importance. Bangladesh since then has been observing "International Youth Day" on 12 August every year in a befitting manner.

(c) Youth Organization Enlistment

Department of Youth Development is entrusted with the responsibility of involving youth organizations in community development programmes. For active participation of youth organizations in the development process, the Department enlists youth organizations. Until June, 2017 a total number of 18,458 youth organizations have been enlisted with the Department.

(d) Youth Clubs Registration

To involve the youth organizations/ clubs in socio-economic development activities by ensuring transparency and accountability of youth organizations "Youth Organizations (Registration & Operation) Act 2015" was passed in the National Parliament on 30-03-2015. For starting the

registration "Youth Organizations (Registration & Operation) Rules 2017" has been approved by the authority. Department of Youth Development has started registration of youth organizations/ clubs according the approved rules in July 2017. Until June 2022 a total of 5,696 youth organizations/ clubs have registered in the Department.

(e) Grant-in-Aid for Youth Organizations

To encourage club based activities, government has created a welfare fund in the name of "Youth Welfare Fund". The amount of capital of this fund is Tk. 15 crore and since its inception in 1985 and till now an amount of Tk. 27 crore 77 lakh 86 thousand has been sanctioned to 14,668 youth clubs/ organizations. In addition, a sum of Tk. 1 crore 85 lakh 79 thousand has also been sanctioned against 2535 youth organizations as grant from Revenue Budget.

(f) Relations with other International Agencies

UNDP, UNFPA, ESCAP, ILO, UNESCO, JAICA and KOICA extend their active support to the programmes of the Department of Youth Development under the Ministry of Youth & Sports. Already 44 volunteers of JAICA, 50 volunteers of KOICA, 97 volunteers of American Peace core and 46 UNVs have left Bangladesh after completion of their tenure.

(g) National Youth Policy

To combat the challenges of 21th century, Cabinet approved the updated National Youth Policy in 2003 and the ongoing youth programmes are being carried out in light of the National Youth Policy. Meanwhile 14 years have passed under the existing National Youth Policy. To cope up with the changing

needs of the time formulation of a new National Youth Policy is desired. BYLC, a leading youth training organization, has been entrusted with the responsibility of drafting the new National

Youth Policy. For this purpose, BYLC prepare a draft of new National Youth Policy consulting with different youth groups, organized workshops at divisional levels and at different centres by collecting opinion of cross section of people of the society. The draft of the new National Youth Policy has been uploaded in the website of the Ministry of Youth and Sports and public notices were published in two National Dailies for opinions of people from all stratas of the society. The draft policy was also presented in the meeting of the Standing Committee on the Ministry of Youth & Sports. Lastly a workshop was organized to finalize the draft National Youth Policy with participation of local and international experts. Finally, National Youth Policy 2017 has been approved by the Cabinet.

(h) Commonwealth Youth Programme

Department of Youth Development organizes Distance Training Courses, Workshops, Seminars, Youth Exchange Programmes in collaboration with Commonwealth Youth Programme, Asia Centre. Until now a total number of 76 officers & youth leaders have so far obtained "Diploma in Youth Development Work" from CYP, Asia Centre. Moreover, 99 participants so far obtained "Diploma in Youth Development Work" conducted jointly by Bangladesh Open University and Department of Youth Development under the distance training programme of Commonwealth Youth Programme, Asia Center.

(i) Commonwealth Award

Eight youth organizers have received Commonwealth Youth Service Award, 7(seven) youth organizers have received Commonwealth Award for Excellence Youth Work from Bangladesh for their outstanding contributions in self-employment and social service since the introduction of Commonwealth Youth Award by the Commonwealth Youth Programme, Asia Centre. One successful self-employed youth has received Pan-Commonwealth Youth Service Award and 3 (three) youth organizers have also received Commonwealth

Youth Silver Award for their exemplary contribution in social and community development.

(j) SAARC Youth Award

SAARC Youth Award Scheme was introduced in 1997 and since then 2 (two) successful youth organizers have received "SAARC Youth Award" for their exemplary contribution in community and social work.

Conclusion

Youths are most energetic, self-confident, creative and productive guiding force of the nation. They have dreams, passions and hopes. They are impatient and dynamic. Their bubbling enthusiasm has to be regulated and utilized by providing an enabling environment. Youth are willing and able to take responsibility for their lives and contribute positively to change society in which they live. Proper guidance and direction can bring them in the forefront of national development so that their potentialities are properly harnessed and they are transformed into valuable human resource. We have no choice but to harness the youth to achieve the UN declared SDGs by 2030 and build a prosperous Bangladesh by 2041. The relentless efforts of the Department of Youth Development under the supervision of the Ministry of Youth and Sports are continuing towards the desired goal. We believe, the strength of youth is the prosperity of Bangladesh.
